- 2) Any and all training programs that the Defendant participated in or completed as mandated reporters of Spanish Congregation Kingdom Hall (Crystal Lake, Illinois.)
- 3) Any and all training programs, instructional letters, and requirements to become an Elder at the Spanish Congregation Kingdom Hall (Crystal Lake, Illinois).
- 4) Any and all training programs, instructional letters, and materials given to Elders regarding receiving confessions and admissions.
- 5) A copy of the formal written confessional process or procedure maintained by the Jehovah's Witnesses.
- 6) List of any and all members of Spanish Congregation Kingdom Hall of Jehovah's Witnesses (Crystal Lake, Illinois) as of July 27, 2006.
- 7) A copy of Watchtower of January 1, 1997.
- 8) All documents, reports, and minutes generated by the Judicial Committee formed on or about July 27, 2006 for Arturo Hernandez-Pedraza
