(b), the judgment or order or any part of it is affirmed or the appeal is withdrawn or dismissed and the Bonded Defendant shall pay the amount of the judgment or order, or the part of it as to which the judgment or order is affirmed, as entered after the receipt of the remittitur, together with any interest which may have accrued pending the appeal and entry of the remittitur, and costs which may be awarded against the appellant on appeal; or (b) the judgment is reversed or vacated in its entirety.
